

**QUITTAPAHILLA WATERSHED ASSOCIATION  
MEETING MINUTES  
ANNVILLE TOWN HALL  
April 18, 2017**

The meeting began at 7:00 PM.

1. Mike summarized the gist of the meeting of the Project Identification & Prioritization Working Group for the Association's Watershed Implementation Plan (WIP), held at Cleona Borough Hall on Tuesday, April 11 (see the minutes of this working group meeting in Appendix A, below).
2. Mike summarized the formation & current composition of the WIP working groups and the deadlines each is facing (see Appendix B, below).
3. It was determined that the Public Education & Outreach Working Group would meet on Tues. May 16 at 6:00 p.m., an hour before the Association's regular monthly meeting at 7:00 p.m.
4. Kent provided an update on the Snitz Creek Project, funded by the PA Fish & Boat Commission (on this project see the [Minutes of Jan. 17, 2017](#) and the [Sept. 29, 2016 grant proposal](#)). Kent reported that Pennsy Supply has generously donated approximately \$47,000 worth of rock for the project; that PA-DEP permits are expected soon; and that hopes are that work will commence in September or October.
5. Stephan Vegoe reported that the Doc Fritchey Chapter of Trout Unlimited is developing public signage to more effectively explain to anglers what is meant by a "Delayed Harvest" fishing zone. The Association agreed to work with Doc Fritchey on the signage.
6. Alicia Norris provided the Treasurer's Report: a total of \$1,010.72 in the bank. In addition to this, Alicia received from Mike \$45 cash (for t-shirts) and a \$10 check (membership fee for 2017 for Stephen Vegoe).
